# ASSiGNMENT

5. The embankment seems pretty steep to you, but the site manager tells you it's fine.

6. An employee attends a toolbox meeting, but makes an uninterested impression.

Do you speak to him about it?  
Or are you simply glad he signed the registration?

# TRUTH OR DARE

7. The client has not yet confirmed whether the ground might be polluted, yet your works are starting tomorrow.

What do you do?

8. You see an employee put on his safety harness and tether himself to a lifting platform.

Do you confront him or compliment him?

9. You see an employee performing grinding operations with concrete, which produces dust. The employee is grinding with water and wearing hearing protection.

10. The scaffolding builder breaks down a scaffold at great height. He only has one lanyard , which means he is not always tethered safely when he moves around. This man has been working for VolkerWessels for years, and he is known to be loyal and trustworthy.

5. As a construction site worker, you have to conduct a safety round. One of the things to inspect is the organisation of the building site.


Has the building site been set up well in this case?
